STATUTORY TUITION FEES FOR FUNDED STUDY PROGRAMMES

Reduced statutory tuition fee

The reduced tuition fee for first-year students will cease to apply from 2024-2025. As of 2024-2025, only second-year students enrolled without interruption in a teacher training programme (the Education exemption category) will remain entitled to the reduced statutory tuition fee. From 2025-2026, this reduction will also cease to apply for these students. The reduced statutory tuition fee is 50% of the standard statutory tuition fee and in 2024-2025 will amount to $\epsilon_{1,265}$ for a full-time study programme and $\epsilon_{1,163}$ for a part-time study programme.

Full-time study programmes

In 2024-2025, the statutory tuition fee for a funded full-time study programme will be $\epsilon_{2,530}$. An exception to this is the full-time Hospitality Management programme, for which the fee will be $\epsilon_{4,000}$. The Higher Education (Quality in Diversity) Act (Wet kwaliteit in verscheidenheid) allows for tuition fee differentiation for study programmes designated as 'small-scale and intensive education' by the Accreditation Organisation of the Netherlands and Flanders (NVAO).

Part-time study programmes

In 2024-2025, the statutory tuition fee for a funded part-time study programme will be €2,327.

The statutory tuition fee for part-time study programmes was raised in 2021-2022. A *transitional scheme* applies for current part-time students. This concerns students who started their current study programme in 2020-2021 or earlier and who have been enrolled in this programme without interruption. The transitional scheme ceases to apply if a student switches study programmes. In 2024-2025, the transition fee will be \leq 1,956.

The transitional scheme applies for a maximum of five years and will terminate after 2025-2026. If the transitional scheme applies to you and you are forced to interrupt your enrolment for more than one academic year due to illness, you can submit a request to the dean of the school to be eligible to pay the transitional rate again.

Dual study programmes

In 2024-2025, the statutory tuition fee for a funded dual study programme will be €2,530.

INSTITUTIONAL TUITION FEES FOR FUNDED STUDY PROGRAMMES

If you do not meet the conditions set out in Chapter 6, Article 6.1, paragraphs 1 and 2, of the Regulations on admission, enrolment and deregistration, this institutional tuition fee will apply.

The institutional tuition fees for funded bachelor's programmes and master's programmes depend on the rate group a study programme is assigned to. The rate groups for 2024-2025 are as follows:

Low €9,600 High €11,550 Top €13,100

The institutional tuition fees have been indexed at over 9% in accordance with the indexation of the statutory tuition fee set by the Ministry of Education, Culture and Science. The categorisation of study programmes into rate groups is shown in the table on the following page.

Students of the Bachelor Music, the Bachelor Music in Education and the Master in Music will pay the top rate through to 2023-2024. As of 2024-2025, these students will pay the high rate. Current students of the Bachelor Music, the Bachelor Education in Music and the Master's in Music who will be paying the top rate in 2023-2024 will be also be paying the top rate from 1 September 2024.

Through to 2025-2026, a transitional scheme will apply for Music students who began their study programme in 2020-2021 or earlier and who remain enrolled in the programme without interruption. These students will pay the transitional rate of €9,600 in 2024-2025. This transitional scheme ceases to apply if a student switches study programmes.

However, an exception applies to students of the Bachelor's in Music who were covered by the transitional scheme through to 2022-2023 and who transfer to the Master's in Music in 2023-2024. These students will pay €8,750 in 2024-2025. This will be implemented by means of a personal discount (waiver) for a maximum of two academic years (through to 2024-2025).

Students with Ukrainian nationality

Students with a Ukrainian passport who were enrolled in the 2022-2023 academic year and who paid their tuition fees to Zuyd University of Applied Sciences or another Dutch institution of higher education are eligible for a reduced institutional fee equal to the statutory tuition fee for 2024-2025.

This reduction of the institutional fee for the academic year 2024-2025 also applies to participants in Zuyd's pre-Bachelor's programme with a Ukrainian passport who were enrolled in this pre-Bachelor's in the academic year 2022-2023.

INSTITUTIONAL TUITION FEES FOR NON-FUNDED STUDY PROGRAMMES

Full-time study programmes

The institutional tuition fees for non-funded full-time study programme are as follows:

- a. €12,170 for the *Master's in Facility and Real Estate Management* (abbreviated FREM); this tuition fee covers the full two-year duration of this programme. The tuition fee is inclusive of the fees payable to the University of Greenwich.
 - 1. The one-year programme is capped off by the final thesis. If the submitted final thesis is given a fail mark, the student will be entitled to improve the thesis and resubmit it within two months without being required to pay an additional tuition fee. If the resubmitted thesis is given a fail mark, the student will be entitled to a third and fourth opportunity with the option to either submit a new thesis or another improved version of the original thesis. In both cases, the student will be required pay an additional tuition fee of €2,800 for these resubmission opportunities.
 - 2. FREM Master's students can compete for one of ten available FREM Master's Scholarships.

Overview of tuition fees and examination fees of Zuyd UAS for 2024-2025

All students admitted to the FREM Master's will receive an email from the study programme detailing the application process for the FREM Master's Scholarships for 2024-2025, which will be provided to the ten best candidates. The Scholarship entails a reduction of the tuition fee by €1,500.

- 3. For the FREM Master's, there is no full or partial refund of tuition fees if students terminate their enrolment after 1 October. Students who leave the study programme between 1 September and 1 October will pay €2,600 to cover the fees payable to the University of Greenwich and administrative costs. They will be refunded the remainder of the tuition fees already paid.
- 4. Students who have already been enrolled in the FREM Master for two academic years and wish to enrol for a third or subsequent academic year will be required to pay a fee of €2,530 per academic year in accordance with the statutory tuition fee.
- b. €11,950 for the *Master's in Scientific Illustration*.
- c. The 2024-25 institutional tuition fee for the non-funded Master's in Leading Hospitality Innovation is €19,500 per student for the entire 18-month duration of the programme. Tuition fees are invoiced with the option to pay at once or in two instalments. Please note the following payment deadlines apply:
 - for non-EU students: for payment in full at once (€ 19,500) the final payment deadline is 15 June 2024. For payment in two instalments, the final payment deadline for the first invoice (€ 9,750) is 15 June 2024, and the final payment deadline for the second invoice (€ 9,750) is 31 December 2024.
 - for EU students: for payment in full at once (€ 19,500) the final payment deadline is 15 July 2024. For payment in two instalments, the final payment deadline for the first invoice (€9,750) is 15 July 2024, and the final payment deadline for the second invoice (€ 9,750) is 31 December 2024.

Reimbursement of tuition fees for the Master's in Leading Hospitality Innovation:

- Non-EU students who leave the programme before 31 January 2025 due to extenuating circumstances are entitled to a 50% refund of the tuition fee. This requires relevant evidence and approval from the programme council.
- EU students who leave the programme before 30 September 2024 are entitled to a full refund of their tuition fees, minus €2,500 administration costs.
- EU students who leave the programme after 30 September 2024, but before 31 January 2025, are entitled to a refund of 50% of the tuition fees paid.
- EU students and non-EU students departing after 31 January 2025 will not be refunded.

Part-time study programmes

The institutional tuition fees for non-funded part-time study programmes are as follows:

a. €26,266 for the **Master's in Personal Leadership in Innovation and Change** (PLIC). Due to the modular structure of this study programme, students follow most of the programme by enrolling as a course participant. Those wishing to follow the Masterpiece Master Class must enrol as a student to enable their registration as a student in BRON-HO. There is a 10% discount for Zuyd alumni and employees. The breakdown of the fees is shown in the table below.

b. €8,060 per year for the *Master's in Facility and Real Estate Management*. €7,350 for students who already started on the FREM Master's in 2023-2024. Tuition fees for the study programme cover the fees payable to the University of Greenwich.

- 1. The final thesis is the final stage of the two-year programme. If the submitted final thesis is given a fail mark, the student will be entitled to improve the thesis and resubmit it within two months without being required to pay an additional tuition fee. If the resubmitted thesis is given a fail mark, the student will be entitled to a third and fourth opportunity with the option to either submit a new thesis or another improved version of the original thesis. In both cases, the student will be required pay an additional tuition fee of €2,800 for these resubmission opportunities.
- 2. FREM Master's students can compete for one of ten available FREM Master Scholarships. All students admitted to the FREM Master's will receive an email from the study programme detailing the application process for the FREM Master's Scholarships for 2024-2025, which will be provided to the ten best candidates. The Scholarship entails a reduction of the tuition fee by €1,500.
- 3. Students who terminate their enrolment in the non-funded FREM Master's after 1 October will be entitled to a full or partial refund of their tuition fee. Students who leave the study programme between 1 September and 1 October will pay €2,500 to cover the fees payable to the University of Greenwich and administrative costs. Students will be refunded the balance of the tuition fee already paid.
- 4. Students who have already been enrolled in the FREM Master's for three academic years and wish to enrol for a fourth or subsequent academic year will be required to pay of a fee of €2,327 per academic year in accordance with the statutory tuition fee for part-time study programmes.

EXAMINATION FEES FOR EXTERNAL STUDENTS

Full-time study programmes

The examination fee for external students enrolled in a full-time study programme is €2,530.

Part-time study programmes

The examination fee for external students enrolled in a part-time study programme is €2,327.

Dual study programmes

The examination fee for external students enrolled in a dual study programme is €2,530.
